GENERAL TERMS AND CONDITIONS

- 1. Renter leases the vehicle under the terms and conditions below for the duration of the rental. The Renter, with his signature, acknowledges that he received the vehicle in proper operating condition, five tires in good condition, with a full tank of gas, complete set of tools, accessories and papers and agrees to return the vehicle under the same conditions on the agreed date, time and place. Renter must notify HIIC of any accidents or damages to the vehicle within 24 hours of the occurrence.
- 2. Renter undertakes that the vehicle will not be used in any case: a) to transport illegal goods or for any other illegal purposes; b) to push or tow any vehicle or any other rolling or non-rolling object; c) in motor sports (rally racing, speed testing or reliability trials or to drive on roads not open to and/or suitable for normal traffic); d) to exceed the limits established by the manufacturer for the number of passengers and/or capacity to be carried in the vehicle; e) by anyone under the influence of alcohol or drugs; f) for paid carriage of passengers or goods whatever the method of payment or the written or oral contract is; g) paid or unpaid to rent to anyone, lend or loan to other than the Renter himself and the person(s) whose signature is registered on the Rental Agreement.
- 3. Renter undertakes to keep the vehicle safely closed and locked when not in use. In the event of theft of the vehicle and the vehicle is found within 30 days, Renter is responsible to pay for the rental charges at the above rates up to the date the vehicle is found. If the vehicle is not found within 30 days, the Renter is responsible to pay the current value of the vehicle.
- 4. Renter undertakes to pay, in the event of loss of car papers and/or plate the reissuing expenses of these items.
- Renter, during the rental period and after delivering back the vehicle, discharges the HIIC from the responsibility of loss or damage of any goods and personal items in or carried by the vehicle.
- 6. HIIC reserves the right to not extend or to cancel this rental contract at any time and for any reason.
- 7. Renter is responsible for all damages to and/or theft of the vehicle or any part thereof including losses due to business interruption and the depreciation of the vehicle not attributable to normal wear and tear. Traffic and parking violations are the responsibility of the Renter. There will be a \$75 handling fee in addition to the fine for any citations processed by HiIC.
- 8. Renter agrees to pay 1.5% interest per month plus attorneys and/or collection fees for all outstanding monies owed to HIIC.
- If vehicle is not approved for extension and not returned on date and time due, then this rental contract is void and will be assumed stolen by Renter and will be reported to the Guam Police Department.
